पुणे : दोन वर्षांनंतर होणाऱ्या लोकसभा निवडणुकीसाठीची तयारी भारतीय जनता पक्षाने सुरू केली असून राष्ट्रवादी काँग्रेसचा बालेकिल्ला असलेल्या बारामती लोकसभा मतदारसंघावर लक्ष केंद्रित करण्यात आले असले, तरी बारामतीचा गड सर करणे भाजपसाठी आव्हानात्मक ठरणार आहे. सर्वसमावेशक चेहरा आणि तुल्यबळ उमेदवाराचा अभाव आणि मताधिक्याचे समीकरण सोडविणे हाच मुद्दा भाजपसाठी अडचणीचा ठरणार आहे.
